RECAPITULATION OF MITIGATION FEATURES
For 14800 Walsingham Rd (Building 9)

1. **Building Code:** **Unknown or does not meet the requirements of Answer A or B**
Comments: The year of construction was verified as 1974 per Pinellas County Property Appraiser.
2. **Roof Covering:** **FBC Equivalent**
Comments: According to association records the roof covering was replaced 2005. We were unable to locate a roofing permit with the local building department; however, in our professional opinion the roof covering was replaced in 2005. The roof covering replacement was confirmed via historical imagery provided by Google Earth and information provided by the association.
3. **Roof Deck Attachment:** **Level A**
Comments: Inspection verified 1/2" plywood roof deck attached with staples at a minimum of 6" on the edge & 12" in the field.
4. **Roof to Wall Attachment:** **Clips**
Comments: Inspection verified embedded straps fastened with a minimum of three nails.
5. **Roof Geometry:** **Other Roof**
Comments: Inspection verified a gable roof shape.
6. **SWR:** **No**
